PARAPROFESSIONAL EMPLOYMENT PROCEDURES

1. Complete an application online at www.ecisd.us
Edinburg CISD employees apply as an Internal Applicant.
External Applicants are required to upload the following:
 - Copy of high school diploma or high school transcript or GED.
 - If applicable official transcript from University.
 - If applicable last 2 years of evaluation forms.
 - One recommendation form must be received from your previous principal or supervisor. At least two other references should be from other supervisors, educators, or someone knowledgeable about applicant's work experience. Do not use family/friends as references.
 - Resume
2. When a vacancy occurs, it will be posted. Paraprofessional vacancies may be advertised as needed.
3. Interviews will be scheduled and conducted by the Principal and SBDM members or Department Head. No offers of employment can be made by any principal or dept. head. The Board of Trustees has final approval.
4. Campus and/or department will submit to Personnel Office the top candidate(s) for the position.
5. Upon Superintendent's approval, he/she will make a recommendation to the Board at the next Board Meeting.
6. Upon Board approval, the employee is notified by the Personnel Dept. and a starting date is established.
7. Applications are kept active for only 6 months.

The District may obtain criminal history record information that relates to a person the District intends to employ.
