- INTENTION: It is the intention of the Board of Trustees of the Edinburg Consolidated Independent School District to receive proposals from interested vendors to provide HAZARDOUS WASTE DISPOSAL SERVICE.

- RENEWAL CLAUSE: This contract may be renewed for an additional two (2) year TERM CONTRACT PERIOD(s), renewed annually, if the vendor and the Edinburg CISD agree and no increases in cost are incurred except for the growth of the district.
