- INTENTION: It is the intention of the Board of Trustees of the Edinburg Consolidated Independent School District to receive proposals from interested vendors to provide JANITORIAL SUPPLIES.
- **CONTRACT SERVICE PERIOD:** This is a term contract beginning August 1, 2025 or soon thereafter and ending July 31, 2026.
- **RENEWAL CLAUSE:** This contract may be renewed for an additional two (2) year TERM CONTRACT PERIOD, if the vendor and the Edinburg CISD agree and no increases in cost are incurred except for the growth of the district.

QUESTIONS ANSWERED: The District will be out from June 30, 2025 - July 18, 2025 and returning on July 21, 2025. Questions will be answered upon return.
